## Loans NOT eligible for skip a pay:

- Visa Credit Cards, Certificate Secured, Personal Line of Credit, Mortgage, Home Equity Loans, or Delinquent Loans.
- Cannot have an extension on loans within the last 12 months.
- Can only skip one month's payment per loan
- Must have made 6 prior consecutive monthly payments.
- Restrictions may apply to Loans with GAP.
- All accounts must be in good standing (example: no overdraft fees or return items).

Commercial loans are not eligible to participate.
